# ASSEMBLY DISTRICT 31 LEGISLATIVE PRIORITIES



As we move forward with the 246th Legislative Session of New York State, I am excited to present my office's legislative and community priorities based on the urgent issues affecting our community:

# **Food Access and Justice**

Food prices have skyrocketed since the COVID-19 pandemic, and many workingclass families are struggling with food insecurity. My office is dedicated to breaking the stigma around food insecurity and hunger as we fight to reform policies that make healthy food hard to access and "junk" food readily available. Food insecurity affects everyone – children, parents, seniors, veterans, college students, and immigrants. My office invites you to join us as we offer solutions to address food insecurity, including SNAP/EBT assistance, nutrition education, and critical investments in our food supply infrastructure.

# **Housing Insecurity**

My office strongly believes that housing is a human right. Every person should have access to safe, decent, and affordable housing, regardless of race, socioeconomic status, or source of income. Amid New York City's affordable housing crisis, my office fights daily to ensure our constituents have a fair opportunity to obtain, maintain, and sustain housing. We work to reconcile the nuances of the housing ecosystem so that renters, homeowners, and small property owners are supported and treated fairly. To be clear – we must provide relief for renters and cut through the bureaucratic red tape that prevents access to housing; we must equip homeowners with resources that promote longevity and intergenerational homeownership; and we must preserve public housing and empower tenants to take control of their future.

# **Structural Violence**

Research shows that food hardship and housing insecurity lead to violence in our communities. Our office is committed to addressing these root causes of violence in addition to poverty, unemployment, failing schools, childhood trauma, mental health challenges, and substance misuse to name a few. Dr. Martin Luther King Jr. once said, "Violence is anything that denies human integrity and leads to hopelessness and helplessness." We condemn violence in all forms – domestic violence, gun violence, school-based violence, and police violence. We invite you to join our office as we fight to transform a criminal legal system that should prioritize justice, restoration, harm reduction, and rehabilitation.

# Advocating for Fairness in Pretrial Detention

On March 30th, I joined advocates and my elected colleagues for a rally against pretrial incarceration, which affects poor Black and Brown people, and denounced the Governor's proposed rollbacks to bail reform. Bail reform was implemented in 2020 to reduce the number of people held in jails while awaiting a fair trial simply because they cannot afford to pay bail. Under the current system, judges have adequate discretion as they are required to consider a person's ability to pay bail and the risk they pose to public safety when making bail decisions. These reforms have helped to promote equity, by reducing the number of people incarcerated pretrial and addressing systemic bias in the criminal justice system.



# **Full Funding for Safety Net Hospitals**

I joined Senator Gustavo Rivera at his Press Conference on April 25th calling on Governor Hochul to fully fund safety net hospitals. These institutions operate on meager budgets and primarily serve communities of color that are largely uninsured or rely on Medicaid reimbursement rates. Our constituents need these services and fundamental changes must be made to how the State finances safety net hospitals to eliminate this two-tiered system of care.



# NYCHA On My Mind

Many New Yorkers still have not fully recovered from the COVID-19 pandemic, including hundreds of public housing residents in my district facing eviction due to rent arrears. Public housing residents deserve better than being placed at the back of the line for the Emergency Rental Assistance Program (ERAP). Here in Albany, I will continue to fight tirelessly for NYCHA and public housing residents to get their fair share.



# Supporting Black Farmers in New York State

On February 14th, I questioned the New York State Department of Agriculture and Markets about what support the state has given to our Black farmers. The Commissioner stated the Department provides outreach, training, and access to financial lending to support Black farmers, but would need more funding from the state to hire additional staff.



# Welcoming Families from Assembly District 31 to ''The People's House''

During each Legislative Session, I have the distinct honor and privilege of welcoming constituents and families from the 31st District to "The People's House" in Albany. This session, I received Pastor Courtney Brown and his lovely family from Upper Room International Ministries, as well as my younger brother, Sekenya, and his beautiful family on the Assembly floor.



# Climate Justice Saves Dollars and Makes Sense

I met with proponents and fully support passage of the "Renewable Heat Now" bill package in New York State. These policies which include improved building codes, appliance standards, and zero emissions of all-electric new buildings, will save New Yorkers money on their energy bill and reduce emissions.

# **Expanding Access for People with Disabilities**

On March 20th, I met with Alphapointe, a nonprofit organization that is one of the largest employers of people who are blind in New York State. They plan to build a 138,000 sq ft building in Richmond Hill to provide employment for people with vision loss. As a member of the Assembly Committee on People with Disabilities, I am committed to supporting these initiatives to help more people who are visually impaired or blind throughout Assembly District 31.



### We Deserve Better Bus Service

Earlier this year, I rode the bus from one end of Assembly District 31 to the other to highlight the long commute times faced by constituents living in Far Rockaway, South Ozone Park, Springfield Gardens, and Rosedale. After the bus ride, I held a press conference in Far Rockaway with Riders Alliance urging my colleagues in Albany to allocate funds for more frequent bus and train service in Queens and the entire city in the state budget.

Our event kicked off a 10-week workforce development and certification program to help Southeast Queens residents affected by Cannabis Prohibition participate in the fast-growing billion dollar industry.
