

Child Victims Act

My colleagues and I in the Assembly and Senate passed the historic Child Victims Act which was signed into law on February 14, 2019. This new law finally gives **victims of child sex abuse** an expanded ability to seek justice against their abusers or negligent institutions. This opportunity provides adult survivors of child sexual abuse the ability to file a civil or criminal lawsuit against their abuser or negligent institutions such as places of worship, schools, organizations... etc., even if the previous statute of limitations may have expired.

3 key components of the Child Victims Act:

1. Victims who were under the age of 23 when the bill was signed into law now have until the **age of 25 to file misdemeanor charges** and the **age of 28 to file felony charges**;
2. Victims who were under the age of 23 when the bill was signed into law now have until **the age of 55 to file a civil lawsuit** against the person who abused them and/or the institution that allowed this abuse to take place;
3. Victims who were over the age of 23 when the bill was signed into law now have a **one year “window” (from August 14, 2019 to August 13, 2020) to file a civil lawsuit** against person who abused them and/or the institution that allowed this abuse to take place, no matter how long ago the abuse happened. Once this one year window expires, this opportunity will no longer be available.

Nouvo lwa sa a bay **timoun ki víktim abi seksyèl** plis posiblite pou yo jwenn jistis kont moun ki abize yo oswa enstitisyon ki fè neglijans nan ka sa yo. Se yon okazyon pou granmoun ki te sibi abi seksyèl lè yo te timoun pou yo gen mwayen legal pou yo fè moun ki abize yo oswa yon enstitisyon tankou lekòl, òganizasyon ak kote moun priye, ki fè neglijans nan ka sa yo pwose sivil oswa pwose kriminèl menm lè tan limit la fin pase.

Twa eleman kle nan Lwa sou Abi Seksyèl kont Timoun:

1. Víktim ki pa te ko gen 23 zan lè pwojè lwa a te tounen on lwa, kounye a **toutotan yo pokò gen 25, yo kapab rele moun ki te fè yo abi seksyèl la lajistis** pou enfraksyon oubyen deli. Epitou, toutotan yo pokò gen 28 an, yo kapab rele moun nan nan tribinal pou krim.
2. Víktim ki te gen mwens pase 23 zan anvan pwojè lwa a te tounen on lwa, kounye a **toutotan yo pokò gen 55 an, yo kapab rele moun ki te abize yo a ak/oubyen enstitisyon ki fè neglijans lan nan tribinal** pou yon pwose sivil.
3. Víktim ki te gen plis pase 23 zan anvan pwojè lwa a te tounen on lwa, kounye a yo gen yon peryòd **yon lane soti 14 Out 2019 rive 13 Out 2020, pou yo rele moun kit e abize yo ak/oubyen enstitisyon ki fè neglijans lan nan tribinal** pou yon pwose sivil kèlkeswa depi konbyen tan abi sa a te fèt. Depi peryòd yon lane sa a espire, opòtinite sa a pa p disponinb ankò.
