- 禁止將無家可歸者收容所設在交通設施附近或租金管制公寓所在的建築物內。(A.6909-A)



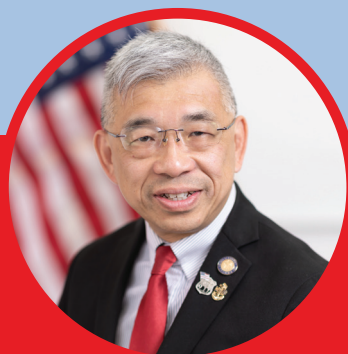
