Read our Second Avenue Subway Update!

After the opening of the Second Avenue Subway, and the unacceptable breakdowns of the elevators that followed, our office has talked to many constituents about the issue with delays. In order to ensure that subway service meets public demand, we are pleased to inform you of the proposed schedule adjustments to the Q line recently announced by the MTA:

- One additional weekday southbound Q trip would be operated from 96th Street- 2nd Avenue, between 8am and 9am, resulting in shorter average headways throughout the morning peak hour.
- One additional weekday northbound Q trip would be operated to 96th Street- 2nd Avenue, between 6:30pm and 7pm, resulting in shorter average headways during the latter part of the evening peak period.

Please let us know about your experience on the Q and any other subway or bus line in the district so we may share your feedback with the MTA.

Seawright's Office Brings You Updates From May 25th RIOC Board Meeting



Updates:

- The Board approved a contract to replace the leaking roof at the Roosevelt Island Youth Center. RIOC authorized the contract with a unanimous vote and chose the least expensive option. The project will last 40 days.
- RIOC President Susan Rosenthal reported that the rat infestation around P.S./I.S. 217 is being addressed. An exterminator inspected the site and rodent poison was placed in the area.
- The Board agreed to ratify the contract with Regimental Contracting for the purchase and installation of water fountains, benches, barbeque grills, and picnic tables at Roosevelt Island Parks. The project will take 90 days to complete with benches being the first priority. Grills will be placed just in time for Memorial Day.
- Authorization of Expenditure of Funds for Roosevelt Island Senior Association.

Upper East Side Elected Officials Demand IMMEDIATE Action to Address East River Esplanade Collapse

Concerned electeds Congresswoman Carolyn Maloney, Comptroller Scott Stringer, Manhattan Borough President Gale Brewer, Senator Liz Krueger, Senator Jose Serrano, Assembly Member Rebecca Seawright, Assembly Member Robert Rodriguez, and Councilmen Dan Garodnick and Ben Kallos were outraged that a significant portion of the East River Esplanade has collapsed into the East River. Assembly Member Rebecca Seawright recently allocated \$500,000 for renovations of the Esplanade from 61st to 79th streets.

The joint letter stated that in late November, a 20 by 10 foot sinkhole opened up, leading to the closure of the Esplanade between 89th and 96th for several weeks. The fact that another collapse has now occurred in the same part of the Esplanade suggests that the problems are more urgent than previously thought and need to be addressed now. The elected officials posed many questions to the Commissioner of New York City Department of Parks and Recreation, Mitchell Silver, including: Why was nothing done to correct the problem before the area deteriorated so badly that there was a collapse? What is the Parks Department's plan to restore and renovate this area? What is being done to ensure that the resources are in place to fix the Esplanade now before any further deterioration occurs? Is the Parks Department conducting a survey to ensure that other places along the Esplanade are not similarly weakened? And, how long will it take for the Parks Department to make the necessary repairs?

*"I am committed to working with the Parks Commissioner Mitchell Silver, Community Board 8 and local elected officials to identify and repair other parts of the esplanade that are susceptible to damage. Our favorite place to play is also our community's first line of defense against flooding. I am pleased to inform you that the Parks Department is currently working to expedite reconstruction which addresses the current condition and a timeline for work is being determined. The site is part of the first phase (\$15M) of the East River Esplanade project. There are two phases, totaling \$41M including \$35M/Mayoral and \$6M City Council. We must make this our priority and bring minds and resources together to address our crumbling esplanade immediately," said **Assembly Member Rebecca A. Seawright.***

Seawright Introduces New York State Constitutional Amendment in a Continued Fight for Equal Rights for Women

In April, Assembly Member Rebecca Seawright announced that her resolution calling on Congress to pass the Equal Rights Amendment had passed the Assembly with bipartisan support.

Now, Assembly Member Seawright is building on that initiative and continuing the fight for equal rights for women. To that end, she has introduced a New York State Constitutional Amendment, A7990, to guarantee equal rights for women.

While New York State is one of the most progressive states in the nation and has tackled issues such as paid family leave, equal rights are not explicitly provided for in the State's constitution.

*"It is unacceptable that the New York Constitution doesn't prohibit discrimination on the basis of sex," **Assembly Member Seawright said.** "With the federal political atmosphere changing, there is a renewed call to ensure that basic equal rights are guaranteed for women. It may seem like a fundamental American value, but we can not simply hope that we are treated equally, it must be guaranteed."*

Rebecca Seawright Introduces Bill to Protect Consumer Privacy

Assembly Member Rebecca Seawright, Chair of the Subcommittee on Consumer Fraud Protection, recently introduced a bill, A7915, which prohibits businesses from requiring personal information to complete a credit or debit card transaction unless such information is required by the credit or debit card issuer.

At present, many businesses in New York and other states across the country require personal information, such as a zip code, when consumers complete credit or debit card transactions, despite the fact that such information is unnecessary when completing an in-person transaction. Such personal information can then be used in customized computer software to perform reverse searches from databases that contain millions of names, e-mail addresses, telephone numbers, and street addresses that are indexed in a manner resembling a reverse phonebook. The software can then match a person's name and zip code with their previously undisclosed address, giving the business the ability to market products to customers and to sell this information to other businesses.

By further defining what constitutes "personal identification information," consumer interests in New York can be better protected. Additionally, by prohibiting such information from being entered electronically, the statute becomes current with the technological advances made since the statute was originally passed in 1987. The bill is on the Consumer Affairs Committee agenda.

Hearing on Quality Child Care



On Tuesday May 23, 2017, the Assembly Committee on Children and Families and the Assembly Task Force on Women's Issues held a joint hearing with the Senate to examine access to quality child care. Seawright, along with her Assembly colleagues called for an investigation into the barriers to accessing quality child day care and examining how such lack of access relates to a variety of issues including child development, family stability, and the economy.

Research suggests that safe and reliable child care is critical to a family's ability to maintain employment and self-sufficiency while promoting positive child development. Despite this evidence, many working families across the state are unable to access quality child care. The lack of affordable day care adversely impacts working mothers and is a barrier for women re-entering or remaining in the workforce. A high percentage of salaries are attributed to child care, which is difficult to find if for those who do not work a traditional nine to five day. The lack of affordable, accessible child care is also an economic concern since it has a direct impact not only on the employee but the employer as well.

Seawright Co-Sponsors 3 Bills on Legislative Disabilities Awareness Day to Improve Quality of Life for Disabled New Yorkers

"A disability should never stand in the way of any New Yorker living a life full of opportunity and equality," Assembly Member Seawright said.

A.2546 was introduced by Assembly Member Barbara Lifton and would ensure that New York State employees can exercise their rights under the Americans with Disabilities Act of 1990, the Age Discrimination in Employment Act of 1967, the Fair Labor Standards Act of 1938 and the Family and Medical Leave Act of 1993.

A.6287 was introduced by Didi Barrett and guarantees that New Yorkers with disabilities are properly protected in the event of an emergency. It requires owners of high-rise buildings to establish an emergency evacuation plan for occupants and visitors with disabilities, update and maintain the plan as necessary, and ensure the evacuation plan is available to emergency personnel.

A.6865 was introduced by David Weprin and demands counties with local emergency management plans to maintain a confidential, voluntary registry of residents with disabilities who may need assistance or shelter during a disaster.

"When it comes to natural disasters – which we are unfortunately experiencing all too frequently these days – and other emergencies, there is no such thing as being too prepared," Assembly Member Seawright said. "These bills will make sure that first responders can better protect and assist people with disabilities."

Seawright Passes RIOC CEO Residency Bill

On May 24, 2017, The New York State Assembly took the lead of Rebecca Seawright and passed Assembly Bill 5481, implementing requirements for the position of Chief Executive Officer (CEO) of the Roosevelt Island Operating Corporation (RIOC). The legislation requires that the next RIOC CEO be a resident of Roosevelt Island or become a resident within six months of appointment, unless the RIOC Board waives this requirement due to extraordinary circumstances.

"Roosevelt Island residents are deeply committed to their community," Assembly Member Seawright said. "The majority of the RIOC Board of Directors are required to live on Roosevelt Island. It is fitting that the Chief Executive Officer, who is entrusted with daily life operations on Roosevelt Island, also has a residency requirement. This is a pivotal step towards self-governance for Roosevelt Island residents, creating accountability and requiring greater transparency."

This bill allows the Board to appoint the CEO of RIOC, determine the term of office and requires that the CEO complies with the rules that apply to public officers. This bill is introduced in the Senate by Senator Jose Serrano.
