As we grieve as a community for all police officers that have been killed or wounded in the lineof duty, we must, as New York City Mayor Eric Adams has said, "Dam the sea of rivers that feed the sea of crime".

The City of New York should strengthen the visibility and deployment of law enforcement, institute a proactive and effective plainclothes unit, and provide more comprehensive mental health services. Heading the list must be a coordinated federal, state, and regional campaign to stop the massive influx of guns from southern states and elsewhere to New York. Every tactic and strategy in the collective toolkit must be utilized to stem the epidemic gun flow which has sustained ongoing criminal activity and threatens all New Yorkers.

We simply cannot make the progress needed towards a humane and just society without placing public safety at the top of our agenda.
