Amy Paulin's recent victories for the people of New York State:

Addressing the COVID-19 Pandemic

- Enabling not-for-profits, business corporations, and religious corporations to hold meetings virtually during the COVID-19 state disaster emergency (Ch. 122 of 2020).
- Authorizing licensed pharmacists to administer the COVID-19 vaccine once approved (Ch. 110 of 2020).

Promoting Health & Safety

- Increasing safety in limousines by requiring seatbelts (Ch. 10 of 2020), pre-employment and random drug and alcohol testing for drivers (Ch. 2 of 2020), and creating a Stretch Limousine Safety Task Force (Ch. 3 of 2020).
- Ensuring that individuals with Crohn's and other gastrointestinal diseases can access restrooms, by
 establishing an ID card (Ch. 310 of 2020) and enabling complaints to be filed with local consumer
 affairs departments (Ch. 208 of 2020).
- Allowing gestational surrogacy and providing certainty as to the legal parentage of children born through assisted reproduction (Ch. 56 of 2020).
- Preventing teenagers from buying vapor products by banning shipment to New York residents (Ch. 56 of 2020).

Protecting the Environment

- Prohibiting non-electric vehicles from parking in a spot designated for charging an electric vehicle, by making it a violation (Ch. 206 of 2020).
- Keeping Westchester green by clarifying that county parkland cannot be sold without state approval (Ch. 201 of 2020).
