# **NEWS YOU SHOULD KNOW**





#### **ENERGY ASSISTANCE**

Autumn may have blessed us with extra sunshine and warmer-than-average temperatures this year, but that doesn't mean that winter is going to be as kind to us. As New Yorkers, we're all too familiar with the harsh weather the season can bring, as well as the high bills that come with it. Fortunately, the **Home Energy Assistance Program (HEAP)** can help cover those costs.

**HEAP**, a federally funded program, provides financial assistance to both renters and homeowners and can be used to help cover the costs of electricity, propane, natural gas, wood, oil, kerosene, coal or other heating fuels. Eligible families can also apply for funds to help pay for home heating equipment and repairs.

Eligibility for **HEAP** relies on a number of factors, including income, household size, primary heating source and whether a member of the household is under the age

of 6, over the age of 60 or permanently disabled. For the upcoming winter, a family of four that has a household income of up to \$4,457 a month may qualify for help. Applications are now being accepted and please know that assistance is granted on a first-come, first-served basis. This year, households can receive up to \$726 in assistance. An extra emergency payment is also available to households that are out of fuel or going to have their service shut off. Applications for an emergency benefit open on January 2, 2018.

#### **ELDERLY PHARMACEUTICAL INSURANCE COVERAGE PROGRAM**

The Elderly Pharmaceutical Insurance Coverage program (EPIC) is a program administered by the Department of Health and helps thousands of income-eligible seniors age 65 and older to supplement their out-of-pocket Medicare Part D drug plan costs. Seniors can apply for EPIC anytime of the year and

it's easy to join the program.

#### **FAMILY PAID LEAVE**

Family always comes first. We drop what we're doing to be by a loved one's side in a time of need and make sacrifices for them in an instant; but unfortunately, selfless actions like those can come with a harsh price tag for far too many people. It can be the difference between food on the table or an empty fridge because for so many New Yorkers, a leave from work simply isn't an option. That's about to change when the state's new **Paid Family Leave Program** begins on January 1, 2018.

Under New York's Paid Family Leave Program, almost all workers will be eligible for paid family leave benefits. This is a drastic improvement over the federal Family and Medical Leave Act, which only offers unpaid leave and covers just 60 percent of the workforce.

New York's program is being phased in, ensuring employers have enough time to adjust and implement it. In 2018, workers will be eligible for eight weeks of job-protected paid leave at 50 percent of their average

weekly wage. In 2019, it will increase to 10 weeks of leave at 55 percent of the worker's average weekly wage up to 55 percent of the statewide average weekly wage, then to 60 percent of the worker's average weekly wage up to 60 percent of the statewide average weekly wage in 2020. By 2021, it will rise to 12 weeks at 67 percent of the worker's average weekly wage up to 67 percent of the statewide average weekly wage.

Together, we are building a stronger New York State. Progressive policies like paid family leave serve as an example across the nation of what we can do to support working families and ensure equal opportunity for all. # SPOTLIGHT ON YOUR HEALTH FOCUS ON STROKE

As a longtime advocate of good health and my ongoing efforts to protect the wellbeing of our families, I find it my duty to continue to bring attention to some of the illnesses that many people are facing but are unaware of.

According to the National Institute of Neurological Disorders and Stroke, stroke is the third leading cause of death in the United States, behind heart disease and cancer, and a leading cause of serious, long-term disability in adults. About 600,000 new strokes are reported in the U.S. each year.

Although stroke is a disease of the brain, it can affect the entire body. The effects of a stroke range from mild to severe and can include paralysis, problems with thinking, problems with speaking, and emotional problems. Patients may also experience pain or numbness after a stroke.

Every minute counts when someone is having a stroke so it is very important to recognize the signs and call 911 immediately. The warning signs of a stroke (a type of cardiovascular disease) include: sudden numbness or weakness of the face, arm or leg, especially on one side of the body; sudden confusion, trouble speaking or understanding; sudden trouble seeing in one or both eyes; sudden trouble walking, dizziness, loss of



balance or coordination, sudden and severe headache with no known cause.

The best treatment for stroke is prevention. If you smoke, quit. If you have high blood pressure, heart disease, diabetes or high cholesterol, getting and keeping them under control will greatly reduce your chances of having a stroke.

### YONKERS GUN TIPS HOTLINE

With over 20 million guns sold in the United States and thousands of deaths caused by guns each year, the greatest agenda that we can implement is to bring awareness to the dangers that illegal guns have on our community and what programs we can put in place to help reduce shootings and gang violence.



No state is left untouched by gun violence but in order to curtail its frequency, the New York State Assembly has created an extensive gun violence protection package that is aimed at creating a sound and responsible gun-

safety plan.


Currently, the City of Yonkers administers a "Gun Tips Hotline" program to help take illegal guns off the streets. Any individual with tips on the location of an illegal handgun(s) is asked to call (914) 377-GUNS. All calls are confidential.

For far too long, communities across New York State have faced the threat of gun violence through gang violence, domestic violence and accidental shootings. We must all begin to play our part in helping to keep and create a safe environment.

# DID YOU KNOW?

It is still a law for our young men to register for the **Selective Service System**. All men who are United States Citizens or Aliens living in the United States and are between the ages of 18 and 26 years old are required to register with the Selective Service.

If men do not register by the age of 26, they can be prosecuted, and if convicted, face very large fines.

Those men that fail to register, if not prosecuted, will become ineligible for Student Financial Aid, United States Citizenship, Federal Job Training, Federal Jobs and Federally Backed Loans (FHA, etc.).


