A new mass vaccination site opens today at the National Guard Armory in downtown Yonkers. The site will have capacity to administer 1,000 doses per

day. Yonkers and Mt. Vernon residents were initially given priority

to make appointments. Starting today all Westchester residents are eligible to make appointments.

We are thankful that the positivity rate continues to decline in Westchester and across the state. Ninety-five percent of first doses allocated to the state have so far been administered, representing over 3 million first doses; first doses received from the federal government. See data by region and county on the State's Vaccine Tracker: <u>ny.gov/vaccinetracker</u>. In addition, New York will begin administering the Johnson & Johnson vaccine

at state-run mass vaccination sites later this week. A <u>new pilot program</u> begins to administer the Johnson & Johnson single-dose vaccine to eligible New Yorkers during overnight hours at the Yankee Stadium, Javits Center and New York State Fair mass vaccination sites. Yankee Stadium will begin administering the vaccine starting Thursday, March 4, and the Javits Center and New York State Fair sites will begin administering the vaccine Friday, March 5.

vaccinate people 65 and older. Individuals with comorbidities and underlying conditions must visit a State vaccine site available HERE. I share the frustration that many have faced in trying to make an appointment. As more vaccination centers and increased vaccine supply are made available access will improve.
