

ENDING ANONYMOUS LLC REAL ESTATE TRANSACTIONS

- The Zebrowski-Skoufis bill, signed into law, lifts the shroud of anonymity on LLCs that own residential properties.
- LLCs must now disclose the names of all members associated with the company at the time of a residential real estate transaction.
- Previously, it had been almost impossible to know the true ownership of these anonymous entities which left municipalities in the dark and unable to hold anyone accountable for code violations, illegal conversions, or fines.
- Ken has led the fight in stricter code enforcement and fire safety in Rockland and throughout the State; this new law will ensure local governments are able to hold someone responsible should they put residents or first responders at risk.

First in the Nation Tip-Over Legislation

- A major highlight this session included the passage and signing of Harper's Law, a first in the nation bill, that prevents furniture tip-over accidents by removing dangerous furniture from stores across the State.
- Harper's Law is named after Harper Fried, a three-year-old Hudson Valley girl who tragically lost her life after a piece of children's furniture fell on her. Assemblyman Zebrowski worked closely with the Fried family as a legacy to Harper.
- Harper's Law requires retailers to only sell furniture that complies with strict federal or industry standards that include a tip-restraint device and a permanent warning label.
- New York State is now the first state in the nation to require potentially life-saving tip restraint devices to be included in the sale of furniture.

PROTECTING DOMESTIC VIOLENCE VICTIMS

- Assemblyman Zebrowski has continued his strong record of protecting domestic violence victims by passing domestic violence reporting legislation.
- This new law allows survivors of domestic violence to report an incident of abuse to any law enforcement agency across New York State.
- Previously, victims would only be able to report the crime where it took place. Too often, this required survivors to return to the location where the abuse took place, which could be dangerous and traumatic.
- This eliminates jurisdictional issues and will hopefully encourage domestic violence victims to come forward.
- Senator Carlucci and Assemblyman Zebrowski authored this bill with the help of a survivor and the Center for Safety & Change.

Keeping Students and First Responders Safe

- Assemblyman Zebrowski has raised the alarm on lax code enforcement and insufficient fire safety inspections in schools in Rockland and across New York State.
- Ken is happy to report that his Fire Safety Inspection Reform bill passed both houses this session. The bill is awaiting signature by Governor Cuomo.
- These reforms completely overhaul and improve the fire inspection process in schools by removing the ability of unqualified individuals to conduct inspections, and hold schools accountable that do not comply with fire inspection requirements.
- The reforms are long-overdue and will provide peace of mind that our school buildings are properly inspected.

PUTTING TRANSPARENCY BACK INTO POLITICAL CAMPAIGNS

- Ken continues to champion a more transparent, open election process.
- Now New York State law, this transparency bill requires all political advertisements including print, internet, television, or radio to have a "paid for by" statement.
- This will force candidates to publicly stand by their statements and end anonymous attack ads.
- This bill is the second half of Zebrowski's Democracy Protection Act, an effort that started with independent expenditure and digital advertisement disclosures, that passed last year.

Additional Legislation by Assemblyman Zebrowski That Is Now NYS Law

- **Protecting Furloughed Federal Employees:** Provided a temporary extension for payment of property taxes for individuals who had been furloughed during the federal government shutdown (A.881).
- **Protecting Domestic Violence Victims:** Doubles the amount of time that domestic violence survivors can sue their abusers from one year to two years (A.1945).
- Ensuring Inclusivity for Deaf/Hard of Hearing Community: Requires places of public accommodation to provide closed captioning on certain televisions upon request (A.2076).
- Continuing Imperative Hep. C Testing: Extends the requirement that hospitals offer Hepatitis C testing ensuring those that are living with the condition seek treatment (A.7671).
