As we approach the end of the year, I wanted to share some news from the State Capitol. I am proud that once again I was among the most effective legislators in Albany, having passed 15 bills in both houses of the legislature. In addition to these legislative victories, I have been working with my colleagues to fight for more roadway repair funding and to close the MTA value gap to provide better service for west of Hudson commuters.

Following the end of session, I have been busy here in the district, as I have partnered with organizations like the Red Cross for a blood drive and to distribute smoke detectors to those in need. I've worked with local not for profits like the JCC, Pride Center, Jawonio, Bridges, and ARC on various projects and also with towns and villages throughout the district to improve infrastructure.

Assemblyman Zebrowski Passes Important Legislation Through Assembly



Repeating last year's success, Assemblyman Zebrowski was once again among the top members whose bills passed during session this year, with 17 bills passing in the Assembly and 15 passing in both houses of the legislature. Bills passed this year range from those that will have a direct impact locally in Rockland County and those with a statewide impact.

Some of the bills that Assemblyman worked to pass would:

- Enact the New York tropical deforestation-free procurement act to ensure companies contracting with the state are not contributing to tropical deforestation (A.5682)
- Allow the Town of Clarkstown to apply for state funding for cemetery restoration (A.7121)
- Expand the "move over" law to include vehicles parked, stopped, or standing on the shoulder of a parkway or highway (A.1077)
- Require water companies to make information available to residents of cooperatives, condominiums, or multi-family dwellings (A.4403)
- Require a report on the replacement of decommissioned or dormant electric generating sites with renewable energy development and energy storage opportunities (A.4386)

Improving Roads in Rockland County

The current state of Rockland roadways is often a concern heard from constituents across the district. During the summer, Assemblyman Zebrowski met with Department of Transportation officials to discuss some of the concerns that have been raised. The DOT also provided updates on pothole filling that it has done over the warmer months to prepare for winter, as well as clean up operations across roadways.

This year's budget saw a \$60 million increase for the Consolidated Local Street and Highway Improvement program, which will help to improve conditions on local roads. In addition, Assemblyman Zebrowski joined his colleagues from across the Hudson Valley to request the DOT make substantial investments in the region in the next five-year capital funding program.

Corporations Committee Corner

Earlier this year, Assemblyman Zebrowski was appointed Chair of the Assembly Committee on Corporations, Authorities, and Commissions. The committee has oversight over important sectors of the state, such as the Metropolitan Transit Authority, Thruway Authority, Power Authority, and the Public Service Commission.

In July, Assemblyman Zebrowski held his first hearing as Chair of the committee to examine existing electric and gas utility rate structures that are regulated by the Public Service Commission. At the end of October, the Assemblyman chaired a roundtable discussion that focused on electric vehicle charging infrastructure expansion and the impact to the electric grid.

This year, 221 bills have been referred to the committee for review and 59 bills were reported out.

Rockland Library Funding

The 2022-23 state budget included \$34 million in capital project funding for libraries across the state. Here in Rockland, that funding has been put to good use, including the substantial renovations made recently at the New City Free Library.

This year, Assemblyman Zebrowski has partnered with the Red Cross on several initiatives, including a blood drive in August and to bring awareness to the importance of working smoke detectors in homes. As part of the partnership, the office is taking requests for smoke detectors and working with the Red Cross to see them installed. This fall, Assemblyman Zebrowski made a visit with Red Cross workers to install alarms for a homeowner in Congers.

Before departing for South Nyack, the group stopped in at Industrial Arts Brewing Company to tour the brewery's facilities. At this unique West Haverstraw complex, Assemblyman Zebrowski talked to the Lt. Gov. about economic development opportunities in Rockland.

Delgado and Assemblyman Zebrowski toured the grounds and had the opportunity to see some of the newly installed art pieces and the work being done to preserve the 12 acre site. Here, they discussed the importance of parkland, recreational opportunities, and preserving the history of our community.
