Assemblyman Carroll: Improving Our Infrastructure

One of the complaints my office receives the most is about the condition of our roads. I take constituents' concerns seriously and make sure your voice is heard in Albany. As I mentioned in my last newsletter, I fought hard for increased funding for the State Transportation Capital Plan as well as increased funding for our local roads and highways. Now, the State Department of Transportation has two major upcoming projects to repave both Route 303 and Route 304. The Route 303 repavement will go from Orangetown all the way north to the intersection with Route 9W. The Route 304 repavement will go from West Nyack Road all the way north also to the intersection with Route 9W. Both projects are scheduled to begin in the Spring of 2026. These projects are long overdue and I'm pleased they are coming to fruition. I'll keep the community updated as work progresses.

Assemblyman Carroll: Supporting Our Local Non-Profit Organizations

Our local non-profit and community organizations provide vital services across Rockland County. I'm proud to support their efforts by attending events or touring their facilities, highlighting their work, and securing state funding to assist with their operations. Recently, I've spent time with Jawonio, The ARC of Rockland, Venture Together, and Meals on Wheels of Rockland.

I was also successful in helping to secure hundreds of thousands of dollars in funding for various local organizations, including People to People, to assist with their food pantry operations; JCC Rockland, to enhance security on their campus; Center for Safety & Change, to support their work fighting against domestic violence; and United Hospice, to support their veterans pinning and child bereavement programs.

Legislative Update



I'm proud that I was the most productive freshman Assembly Member during the 2025 legislative session, passing 11 bills through the Assembly, more than any other first-term legislator. I'm looking forward to the next legislative session in Albany where I'll continue my focus on making New York safer and more affordable, protecting consumers, and expanding access to sick leave.

Some of my priority legislation includes A.8381, makes impersonating a firefighter a first degree felony; A.6289, increases fines on bad actors who illegally convert buildings putting occupants and emergency service responders at risk; A.9158, allows accrued sick leave to be used for bereavement purposes; and A.9107, requires data centers and other large energy use facilities to pay their fair share of energy consumption.

Assemblyman Carroll Blasts Federal Court Ruling Overturning the Save the Hudson Act

I was extremely disappointed that a federal court ruled to overturn the Save the Hudson Act, a state law that banned the discharge of radioactive water into the Hudson River. In recent decades, community leaders, environmental activists, and elected officials have worked together to clean up the Hudson and prevent further pollution. Allowing the discharge of radiological water would be a catastrophic step backwards.

The Hudson River must never again be a dumping ground for polluters. I've called on the State of New York to appeal this case. I will continue to do my part to protect the Hudson River and its wildlife.
