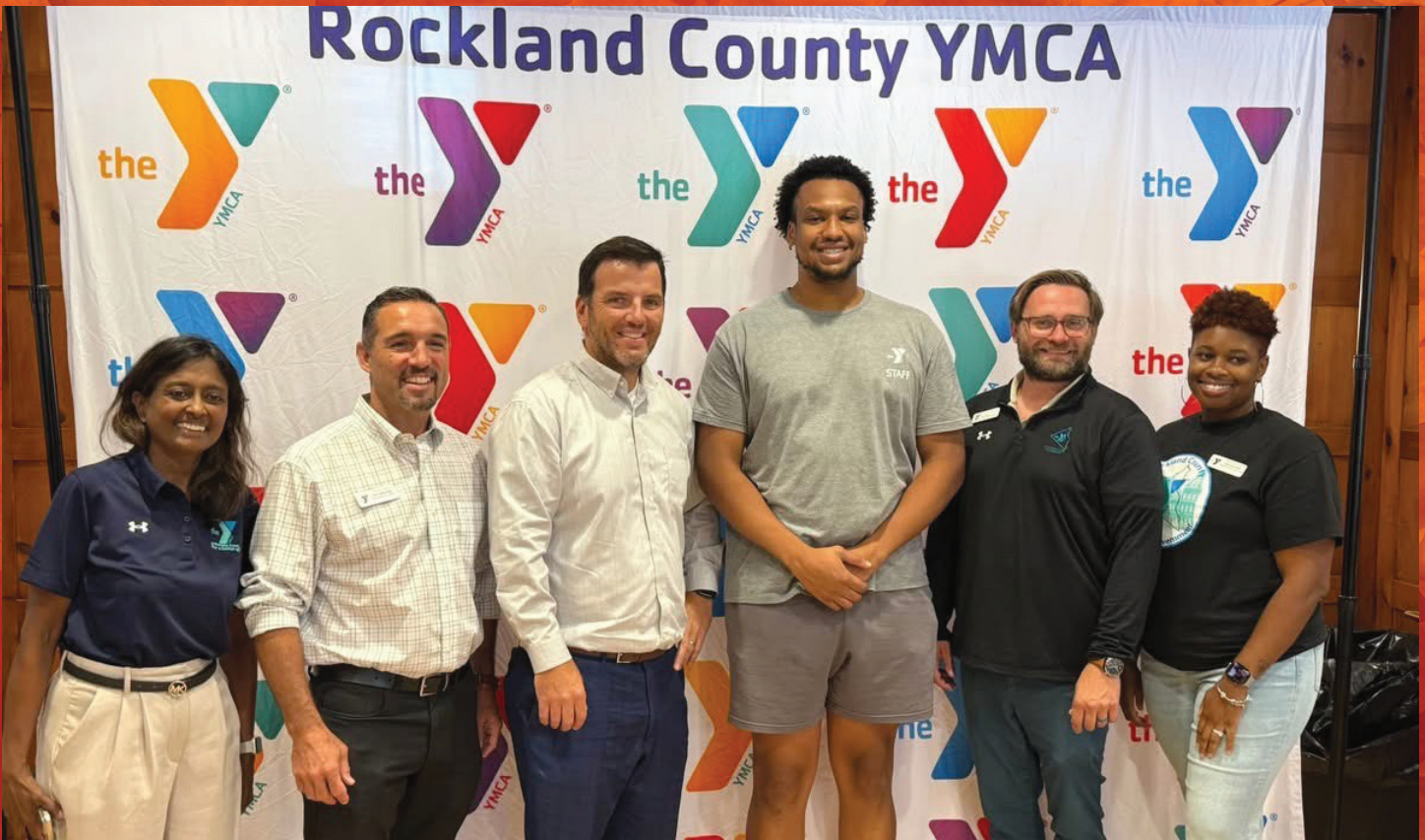

Assemblyman Carroll was joined by former Assemblyman Kenneth Zebrowski, the United Way of Rockland County, and Rockland Community Against Hunger at Soup Angels of Nyack to announce \$75,000 in state funding for vital equipment for 19 food pantries across Rockland. The funding allowed the food pantries to purchase refrigerators, freezers, shelving, hand trucks, and additional equipment.



Assemblyman Carroll Delivers Funding for Nyack

Rockland County sends a lot of tax dollars to Albany and we don't always see it return to our communities. One of my priorities as your Assemblyman has been to make sure that Rockland gets our fair share of funding from the state. I worked hard to secure capital grants and operational funds for our municipalities and non-profit organizations, a significant amount which will go to Nyack. I'm proud that I was able to allocate \$150,000 to the Village of Nyack to retrofit the Department of Public Works garage to create a wash bay for the Village's snow plows and garbage trucks. I also secured nearly \$100,000 for recreational and educational programs in the Village for our children.



In September, Assemblyman Carroll visited the Rockland YMCA to tour their facilities and see their programs in action. He was proud to allocate \$50,000 in state funds to support the operation of their summer camp and Youth in Government program. Assemblyman Carroll Making Our Streets Safer

My office has received numerous complaints about the need to improve pedestrian safety at the intersection of Route 9W and High Avenue. The intersection is in the vicinity of Nyack Hospital; and Nyack Middle School students cross the street here to go to and from school. Following my request that the State Department of Transportation (DOT) implement additional safety measures, they have agreed to install a pedestrian signal and crosswalks at the intersection. While construction won't begin immediately, I'll share further updates when a timeline becomes available.

Legislative Update



I'm proud that I was the most productive freshman Assembly Member during the 2025 legislative session, passing 11 bills through the Assembly, more than any other first-term legislator. I'm looking forward to the next legislative session in Albany where I'll continue my focus on making New York safer and more affordable, protecting consumers, and expanding access to sick leave.

Some of my priority legislation includes A.8381, makes impersonating a firefighter a first degree felony; A.6289, increases fines on bad actors who illegally convert buildings putting occupants and emergency service responders at risk; A.9158, allows accrued sick leave to be used for bereavement purposes; and A.9107, requires data centers and other large energy use facilities to pay their fair share of energy consumption.

Assemblyman Carroll Blasts Federal Court Ruling Overturning the Save the Hudson Act

I was extremely disappointed that a federal court ruled to overturn the Save the Hudson Act, a state law that banned the discharge of radioactive water into the Hudson River. In recent decades, community leaders, environmental activists, and elected officials have worked together to clean up the Hudson and prevent further pollution. Allowing the discharge of radiological water would be a catastrophic step backwards.

The Hudson River must never again be a dumping ground for polluters. I've called on the State of New York to appeal this case. I will continue to do my part to protect the Hudson River and its wildlife.
