



Some Bills I Sponsored this Session

- Would enact the NY Food Insecurity, Farm Resiliency and Rural Poverty Act, which partners the state's farms with local food banks to ensure farmed product does not spoil before being enjoyed (A.3623)
- A proposal to include additional agriculture education in New York's schools (A.3638)
- Adds in additional flavored milk options for school lunches for increased nutritional variety and support of New York's dairy industry (A.3640)
- Would extend protections under the existing "endangering the welfare of a child" statute to include 17-year-olds (A.4145)
- Seeks to empower citizens to recall and remove elected statewide officials (A.5263)
- A proposal to expand property protection by prohibiting the damaging of property to promote or suppress a political ideology (A.7865)
