LEGISLATIVE HIGHLIGHTS

I passed 18 pieces of legislation during the 2025 Legislative Session. Here are a few highlights:

Passed Both Houses

- To expand housing for veterans, I spearheaded a bill that would allow the Veterans & Community Housing Coalition (VCHC) to build new housing units for veterans (A.7312). I secured agreements from state agencies to transfer unused land, formerly the Wilton Development Center Property, to VCHC.
- ✓ To support our conservation and sportsmen's organizations, for the sixth year in a row, I pushed for legislation to **allow the** use of crossbows in big game season statewide (A.8330-A). Crossbows will enable seniors with disabilities to participate in the hunting season while helping to keep the deer population under control.
- ✓ My constituents will always be my highest priority. After speaking with an ER nurse and consulting research on increasing workplace assaults with limited police reports, I developed legislation to allow assaulted healthcare workers to make a report at their workplace rather than the police station (A.6055-A).

Passed the Assembly

✓ To expand the life-saving gifts of organ donation, I developed a bill to facilitate **Eye and Tissue Donation** when a donor has passed away outside of a hospital setting (A.6824-B). One donation of tissue can potentially heal or save up to 75 lives, and donations are viable for up to 24 hours after a donor has passed away.

RESOLUTIONS AND PROCLAMATIONS

This year, I introduced and passed numerous resolutions to honor the contributions of individuals and organizations that are making a positive impact on our state.

Beef Month Sponsorship

I sponsored and passed a resolution declaring May 2025 as Beef Month in the State of New York (K.448). Our state is home to nearly 13,000 cattle farms that have 1.4 million cattle and calves, including almost 110,000 beef cows. About 37,000 of these cattle and calves reside on farms in Saratoga and Washington counties. In partnership with NYS Beef Council, I sponsored "Beef Day" in the Well of the Legislative Office Building, allowing legislators, staff and visitors to the Capitol to sample some of New York's delicious beef.





2025 Constituent Survey

Providing valuable input on budget and policy priorities. Bridge and Road Infrastructure, Health Care, Water and Sewer Infrastructure, K-12 Education and Workforce Development were the top five priorities identified in the survey.





STATE BUDGET

Here's how we've tackled these issues in the 2025-26 state budget:

Investing in our Infrastructure

- √ \$7 billion for the fourth year of the five-year DOT Capital Plan to ensure roadways and bridges are safe and reliable
- ✓ \$100 million more in CHIPS funding over the next two years to help improve our local roads and highways
- **♦ \$500 million** for water and sewer infrastructure projects

Fostering Healthy Families

- ✓ Increases the Medicaid rate for hospitals by \$500 million, with \$30 million allocated to nursing homes
- \$58 million for the Hunger Prevention Nutrition Assistance Program
- \$55 million for Nourish NY
- Secured funding for Comfort Food Community, Pitney Meadows Community Farm and many local food pantries across
 the district
- **♦ \$50 million** additional funding for Upstate Childcare



Educating Future Generations

- ✓ \$37.6 billion in general support for public schools, an increase of \$1.7 billion
- √ \$340 million to provide free school meals for all New York students, projected to save families \$165 per child in groceries each month
- √ \$28.2 million for SUNY community colleges to fund The New York Opportunity Promise
 Scholarship, providing free community college tuition, including the cost of books, fees and
 applicable supplies, to students aged 25-55 pursuing degrees and then careers in highdemand fields
- ✓ An additional \$5 million for New York's summer youth employment program, connecting kids with summer jobs to help them learn important life skills while earning a paycheck
- **♦ \$1.7 million increase** in library aid, for a total of \$106 million
- Authorizes the state Education Department to issue an additional extension of up to 24 months for school districts that are unable to comply with the requirement to purchase only zero-emission buses by 2027
- Secured funding for the Girls Construction Summer Camp run by Northeast Construction Trades Workforce Coalition

RACING AND WAGERING

I am pleased to have been appointed to chair the Assembly Standing Committee on Racing and Wagering. Saratoga Springs resident Susan Steer joined my staff as Deputy Legislative Director and Committee Clerk. This ten-person committee is responsible for budget and legislation related to thoroughbred and standardbred racing, charitable gaming, lotteries, casinos and sports wagering.

Assembly Committee Chair

- ✓ Established a focus on problem gaming and on modernizing charitable gaming
- ✓ Secured an additional \$6 million for the Department of Problem Gaming in the Office of Addiction and Substance Abuse Services
- Championed legislation to ban predatory online sweepstakes games that mimic
 casino games, which are frequently marketed to youth and that can lead to gambling
 addiction, passed (A.6745-A)

✓ Fought for two bills to modernize charitable gaming – one increasing the number of bingo games a charitable organization can host in a year to 30 (A.3681-A) and the other related to an electronic version of the traditional "bell jar" game that many American Legion and VFW posts have onsite (A.7475-B)

My office handles a large volume of constituent cases, ranging from permitting and licensing to unemployment claims, retirement/pension issues and housing. Hats off to District Manager Kim Sheridan-Dugmore, who resolves these issues on behalf of constituents facing challenges with the state government. So far this year, we have opened 117 constituent cases and successfully closed 91, with ongoing efforts to resolve the remaining open cases.


