"Qualified immunity holds that government officials such as police officers cannot be held accountable in civil court unless the rights that were violated are already clearly established in existing case law. This doctrine allows many officers who have engaged in misconduct and abuse to walk freely with little or no consequences."

"Civil asset forfeiture is the practice of confiscating money or assets when it is believed that they were obtained as proceeds of a crime or used to commit a crime. Civil asset forfeiture started as a way to undermine the profitability of large illicit drug operations, but has since been used in conjunction with small infractions. Even when an individual has criminal charges dismissed, that does not clear their belongings. The legal cost to obtain the lost goods or money is often in excess of the value, which leads to many people walking away from their property despite their innocence of the initial purported crime."

### **Legislative Spotlight**

While it has been a tumultuous year, my Assembly colleagues and I were still able to pass meaningful legislation that will help improve the lives of families in the 128th District and across the state. I sponsored and passed a law allowing tenants to deduct water payments from their rent if their landlord fails to cover costs they were contractually obligated to pay (Ch. 143 of 2020).

I also sponsored and passed legislation, which is now awaiting the governor's signature, to restore driver's licenses that were suspended due to traffic debt and require income-based payment plans be made available for fines, fees and surcharges incurred due to traffic violations. In addition, I passed a bill to impose a 2% occupancy tax for hotel stays in Onondaga County to help close the revenue gap without burdening residents.

As we look toward 2021, I'm ready to hit the ground running with several pieces of legislation that tackle the most pressing issues facing our families:

#### **Health Care**

- Establish a program to incentivize unemployed individuals to enter jobs in health care (A.10765)
- Establish a state stockpile of personal protective equipment (PPE) (A.10938)

#### **Veteran Support**

 Ensure veterans have access to our courts to seek legal recourse for chronic illnesses caused by exposure to toxic burn pits overseas (A.11119)

#### **Criminal Justice Reform**

- Require members of the Syracuse Police Dept. to reside within the city limits (A.11008)
- Provide a civil action for deprivation of rights by any person or public entity, which will help dial back the legal principle known as qualified immunity to ensure that those that have been wrongfully deprived of their rights can seek justice (A.10978)
- Criminal Forfeiture Process Act, which would bring due process to the practice of asset forfeiture while preserving the tools law enforcement and district attorneys need to bring down criminal enterprises
