Concerts and live entertainment are a multi-billion-dollar industry in New York State. Chapter 358 of the Laws of 2022 updated the laws regulating tickets sales for these events to enhance protections for consumers. Significant changes were made regarding how ticketing software may be used to purchase tickets, the operations of online ticketing marketplaces and notably, the introduction of all-in ticket pricing. These changes were made to enhance consumer experiences and to make the ticketing industry more transparent. These laws that guide live ticketing for entertainment events in New York State are set to expire on June 30, 2025, giving the Legislature the opportunity to reflect on the impact and effectiveness of prior changes and review potential updates. Such changes have broad implications for promoters, brokers, venues, artists, and consumers throughout the state. This hearing is intended to examine enforcement and implementation of the current ticketing laws as well as gather information from such stakeholders on how to improve the live ticketing experience statewide.

The Committee is interested in receiving feedback from various stakeholders regarding current live entertainment ticketing practices and how such practices impact the industry and consumer experience. Testimony should also include feedback on enforcement of these practices, an examination of current protections, and next steps for renewing and enhancing the laws that govern ticketing for live entertainment events.

Oral testimony will be limited to 10 minutes' duration. In preparing the order of witnesses, the Committee will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated as early as possible.

Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committee would appreciate advance receipt of prepared statements.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.
